The newest issue of *Series in Linguistics, Culture and FLT*

It is our pleasure to welcome you as a collaborator in the latest issue of the journal of the Department of English Studies at Shumen University, Bulgaria, *Series in Linguistics, Culture and FLT*.

The papers accepted for publication should be original scholarly contributions within the fields of Linguistics, Culture, and FLT and may fall under one of the following three categories:

- Research papers involving empirical investigations and methodological or theoretical analyses and discussions within the field of English Studies (min. 7 and max. 15 pages up to 27 000 characters without spaces).
- State of the art reviews (max. 15 pages) and reports of recent books (max. 2 pages) covering issues related to the topic of the journal.
- Notes and squibs (max. 6 pages).

Any additional page will incur an additional cost of 10 Euro per page.

Accepted papers will undergo double blind peer-review and upon approval would be published in the latest issue of *Series in Linguistics, Culture and FLT*, ISSN 2534-9538, SIF 2018 = 4.685, SJIF 2017 = 4.163, SJIF 2016 = 3.363.

**OFFICIAL LANGUAGE:** English

Please **do not** include your name or affiliation in the file that contains your paper. Name that file FULL PAPER\_SILC 2019.doc. It should contain **only** your paper: the title, the abstract, the key words, the body of your text, and the references.

Please send information about your **full name, affiliation, and e-mail address**, along with **the title of your paper** as a **separate** Microsoft Word document. (e.g. SILC 2019\_Author.doc).

**Title, abstract and key words:** the title is centred and written in Times New Roman 11, ALL CAPS Bold.

One blank line, the abstract in English /**Abstract**/: A concise and factual abstract is required (maximum length 200 words; Times New Roman 10 / Italic/). It should state the topic and purpose of the research, the key results and conclusions.

Uncommon abbreviations should be avoided, but if essential they must be spelled out at their first mention in the abstract.

On the next line, Times New Roman 10 /Italic/ key words in English /**Key words:** up to 5.

One blank line, the text of the article, formatted as follows:

**Page Setup:**

Margins: Top – 2.2 cm; Bottom – 2.2 cm; Left – 2.2 cm; Right – 2.2 cm.

Paper Size: Envelop B5 Custom size: Width: 17.5 cm; Height: 25.0 cm

Layout: Header: 1.4 cm, Footer: 1.4 cm

Format: Font - Times New Roman; Font Style - Regular; Size - 11

Paragraph: Line Spacing All: 1; Alignment: Justified; Spacing: After - 6 pt.

Indentation: none

Pages **should not** be numbered.

**Citation:** Citations of more than 4 lines start at a new line – Times New Roman 10, Regular, justified, indent on the left and on the right 0.5 cm. Authors cited in the text are marked as follows: (Spasov, 2002, p. 122) (Popov, Popova, 1975, p. 13).

**Notes:** Footnotes are preferred to endnotes, formatting: Times New Roman 8, Regular, justified and numbered in Arabic numbers.

**References:** One blank line after the text the works cited are ordered alphabetically, font size New Roman 10, Regular, justified:
